1inch Developer Portal Terms of Service

Last updated: May 20, 2024

These 1inch Developer Portal Terms of Service ("**Terms**") constitute a legally binding contract between you and 1inch Limited, a BVI company registered at: c/o Walkers Corporate (BVI) Limited, 171 Main Street, PO Box 92, Road Town, Tortola VG1110, British Virgin Islands ("**1inch**" or "**we**"). These Terms govern your use of 1inch Developer Portal <u>portal.1inch.dev</u> ("**1inch DevPortal**"), 1inch Public API, as defined below, all products and services available via the DevPortal (collectively, the "**Service**").

These Terms also incorporate <u>1inch Developer Portal Privacy Policy</u>, which is incorporated herein by reference. If you want to access 1inch Commercial APIs, please refer to <u>Commercial API Terms of Use</u>.

By accessing, browsing or otherwise using 1inch DevPortal, or by registering and acknowledging agreement to the Terms, you agree that you have read, understood and accepted all the terms set out below or incorporated herein by reference. If you do not agree to be bound by the Terms, please do not proceed with the use of the Service.

1. Definitions

"Public API" or "1inch Public API" means an application programming interface available at 1inch DevPortal for non-commercial use by the User under these Terms, any object code, software libraries, software tools, sample source code, published specifications and Documentation, any future, updated or otherwise modified version(s) thereof.

"Public Endpoint" designated Endpoints for Public APIs.

"Documentation" includes, but is not limited to API keys and any other logins, credentials, tokens, programmer guides, manuals, materials, legal terms and other information appropriate or necessary for use in connection with 1inch DevPortal.

"User", "you", or "your" means you, provided that you are an individual over the age of 18, or the authorized representative of an entity that will be granted access to the Service.

2. Service

1 inch DevPortal provides access to the Public APIs, Public Endpoints and related services and functionalities ("Service"). The Public API is available free of charge for non-commercial use only, subject to the terms and conditions outlined below. If you wish to use our APIs for commercial purposes, and/or beyond the Public API usage limits specified below, and/or for any other purposes not explicitly prescribed by these Terms, you must purchase Commercial APIs under the Commercial API Terms of Use.

We continuously improve our Service and from time to time we may release the updated versions of the Service. Please note that we reserve the right to disable the older version of the Service upon reasonable time following the release of a new version.

1inch Public API. The Public API is intended for personal and non-commercial use only, meaning that it cannot be used or directed toward any commercial value or advantage, or to receive any monetary or other compensation by any individual or legal entity, or otherwise commercially benefit therefrom.

Usage Limits. The Public API is subject to usage limitations as follows:

- Request Per Second Limit (RPS Limit): You shall not exceed one (1) request per second.
- Monthly Request Limit: You shall not exceed one hundred thousand (100 000) requests per month.

1inch reserves the right to change the Usage Limits at any time and in any way at its sole discretion without any prior notice or other obligations to you whatsoever.

We also reserve the right to monitor your use of the Public API and Public Endpoint, including, but not limited to your usage patterns, number of requests made, to improve the Service and ensure that you comply with these Terms.

Usage Limits Exceedance. Your usage of Public API and Public Endpoint may be monitored on a daily basis for a 24-hour period. If we determine, at our sole discretion, that you have exceeded the error rate of the forty percent (40%) of the RPS Limit within a 24-hour period, or exceed the Monthly Request Limit, you shall be subject to the compliance procedure as outlined in Section 8 of these Terms.

We may send notifications regarding compliance procedure to the email address you provided at the time of registration. While we make reasonable effort to send such notifications, we cannot guarantee their delivery and we shall not be liable for any missed or undelivered notification. It is your sole responsibility to monitor your email address and ensure its accuracy.

You hereby acknowledge that your access to the Public API and Public Endpoint shall be temporarily suspended until you successfully complete the compliance procedure. Your refusal to undergo the compliance procedure or failure to complete the compliance procedure will lead to the refusal of your access to the Public API and Public Endpoint without notification.

Should you repetitively exceed any Public API Usage Limits, or violate these Terms in any other manner, we reserve the right to suspend or terminate your access to the Public API immediately without notification.

To enhance security and safety of the 1inch and Service environment and systems, subject to 1inch's internal controls, the User hereby covenants to integrate the Public Endpoint into the customer's application in any technically viable way (as applicable), which at all times shall facilitate that the network requests sent to the Service by the User or the User's end users contain the data on the wallet address of the end users. For the avoidance of doubt, the User shall not circumvent the obligation stated herein by directing the end user's network request through a proxy or intermediary address, or in any other way that would hinder 1inch's ability to determine the wallet address of the originator of the network request.

Commercial Level. Your use of the APIs for commercial purposes, beyond the Public API Usage Limits, and/or for any purposes not covered by these Terms, shall be subject to specific subscription plans or custom plans under the <u>Commercial API Terms of Use</u>. The pricing model may vary based on the respective terms tied to the selected plan. The terms of available subscription and custom plans may be provided on the 1inch DevPortal. We may modify any terms of the Commercial Level, including any

changes to subscription or custom plans, pricing models and/or usage limits at any time, at our sole discretion, without prior notice.

You hereby expressly agree that you shall not under any circumstances use the Public API for commercial purposes or other purposes not explicitly prescribed by these Terms prior to entering into the Commercial API Terms of Use or executing a separate agreement and receiving the necessary approval from 1inch as set forth herein. If you need to use the API for purposes that are not covered by these Terms or the Commercial API Terms of Use, please contact us at csm@1inch.io.

3. Registration

To access the Service, you are required to create an account by registering and accepting these Terms. By doing so, you agree to provide accurate, current, and complete information. Additionally, you agree to promptly update us with any changes or amendments to your submitted information. We reserve the right to reject your registration at our sole discretion. To complete the registration you may be required to pass the Compliance Procedure as set forth in Section 8.

You are responsible for maintaining the security and confidentiality of your account credentials. You agree to notify us immediately if you suspect any unauthorized use of your account or password. We reserve the right to terminate your account or restrict access to the Service if we suspect any unauthorized use or breach of security related to your account or at any other moment at 1inch's sole discretion.

4. Grant of License

1 inch hereby grants you a limited, non-exclusive, world-wide, non-transferable, non-sublicensable, royalty-free right to access and use the Public Endpoint exclusively for the limited non-commercial purposes as set forth herein. You may not distribute, license (whether or not through multiple tiers), or otherwise transfer Public API to any third party, nor may you use it for commercial purposes. Unless otherwise is specified in these Terms, you shall not, directly or indirectly:

- 1. Copy the Public API, unless it is necessary to exercise your rights hereunder;
- 2. Use the Public API and/or Public Endpoints for commercial purposes, or any other purposes not expressly permitted hereunder;
- 3. Sublicense, assign or otherwise transfer your rights hereunder. The rights granted under these Terms are personal to you alone and you may not transfer them to any third party. All rights not expressly granted are reserved by 1inch and, except as expressly set forth herein, no license is granted by 1inch under these Terms directly, by implication, estoppel or otherwise, under any patent, copyright, trade secret or trademark or other intellectual property rights of 1inch;
- 4. Use 1inch's trademarks or trade names in your advertising, marketing, promotional, sales or related materials, without 1inch's express prior consent;
- 5. Assert any patent rights related to the Public API or applications developed using the Public API and/or Public Endpoint against 1inch, 1inch's distributors, 1inch users, or other Users of the Public API and/or Public Endpoint for making, using, selling, offering for sale, or importing any products or technology developed using the Public API and/or Public Endpoint.

5. Intellectual Property Rights

1 inch or its licensors shall own and retain all proprietary rights, including all patent, copyright, trade secret, trademark and other intellectual property rights, in the Public API, Public Endpoint and Services and any corrections, bug fixes, enhancements, updates, improvements, or modifications thereto ("1inch Intellectual Property") and you hereby irrevocably transfer, convey and assign to 1inch all of your right, title, and interest therein.

1 inch shall have the exclusive right to apply for or register any patents, mask work rights, copyrights, and such other proprietary protections with respect thereto. 1 inch shall have a perpetual, non-exclusive, royalty-free, world-wide license to incorporate into 1 inch Intellectual Property or otherwise use any suggestions, enhancement requests, recommendations or other feedback it receives from you ("Suggestions"). You agree that 1 inch has no obligation to you in connection with any Suggestions you submit to 1 inch, and that 1 inch is free to use any Suggestions without any attribution or compensation to you.

You acknowledge that the license granted under these Terms does not provide you with title or ownership, or control over the manner and distribution of the Service, but only a right of limited use under these Terms.

6. Restricted Use

You hereby covenant to:

- avoid deceptive, misleading or unethical practices that are, or might be, detrimental to 1inch;
- make no false or misleading representations with regard to 1inch;
- not publish, employ, or cooperate in the publication any misleading or deceptive advertising material with regard to 1inch;
- not reverse engineer, decompile, modify, disassemble or otherwise alter the Public API, Public Endpoint, Service or any part thereof or otherwise reduce the Public API to human-perceivable form in whole or in part, except and only to the extent that such activity is expressly permitted by these Terms or applicable law;
- not disassemble, decompile, or reverse engineer the software components of the Public API, Public Endpoint, Service or any 1inch Intellectual Property that you may obtain access to;
- not interfere with or disrupt the integrity or performance of the Service;
- not attempt to gain unauthorized access to the Public API, Public Endpoint, Service or their related systems, networks or software;
- not remove, alter, or obscure any proprietary notices embedded with the Public API, Public Endpoint or Service, including copyright notices;
- not make any statement regarding your use of the Public API, Public Endpoint and/or Service which suggests partnership with, sponsorship by, or endorsement by 1inch; and
- not cause or permit any third party to do any of the foregoing; or interfere in any manner with the enjoyment of the Service of any other user.

7. Representation and Warranties

By registering, you acknowledge, warrant, and agree that:

you have full right, power, legal capacity and authority to enter into and be bound by these Terms;

- you are not subject to the Sanction Lists and you are not a Restricted Person, as defined in <u>1 inch</u> Network Interface Terms of Use;
- you are solely and entirely responsible for compliance with all laws and regulations that may
 apply to you. 1inch has no obligation to inform you of any potential liabilities or violations of law or
 regulation that may arise in connection with your access and use of the Service and 1inch is not
 liable in any respect for any failure by you to comply with any applicable laws or regulations.
- you are solely responsible for any decision to use the Public API, Public Endpoint and Service, including the evaluation of any and all risks related to any order;
- you are acting for your own account, and not as a nominee or agent for any other person;
- you are a sophisticated user and possess the necessary knowledge, skills and experience to consume the Service;
- you are fully familiar with the inherent risks involved in these Terms, including, without limitation, risk of new financial regulatory requirements, potential loss of money and risks due to volatility of the price of digital currency, and you voluntarily take full responsibility for any risk to that effect.

8. Compliance Procedure

Prior to using any Service, or in any case defined by these Terms, at 1inch's sole discretion, you may be required to complete know your customer (KYC), know your business (KYB), and anti-money laundering (AML) compliance screening ("Compliance Procedure").

The Compliance Procedure shall be conducted by 1inch or a third party indicated by 1inch, subject to 1inch's internal KYC/KYB and AML policies. You may be asked to answer several questions and upload basic identifying documents.

The data is collected to comply with applicable legal and regulatory obligations (e.g. anti-money laundering or sanctions laws/regulations) in order to verify your identity and determine your legal eligibility. This data is securely maintained and disclosed only when permitted by law. For more information on how your personal data is processed please read <u>1inch Developer Portal Privacy Policy</u>.

You hereby acknowledge that (i) prior to the completion of the Compliance Procedure, or (ii) in case of the failure to complete Compliance Procedure, 1inch reserves the right to refuse your access to the Service. Besides, you shall be subject to the primary and regular ongoing compliance screening, failure to pass which, at all times, will lead to the refusal of your access to the Service.

9. Fees and Payment

1 inch provides the Public APIs free of charge under these Terms. However, we reserve the right to start charging fees at any moment at 1 inch's sole discretion with no prior notification whatsoever. If 1 inch decides to charge for access to the Public API and Public Endpoint, you do not have any obligation to continue to use such Service.

Your use of the API at the Commercial Level is subject to fees and payment terms as defined in Commercial API Terms of Use.

10. Support

1inch has no responsibility for providing you with any support for 1inch DevPortal or Public APIs or Public Endpoints. Nothing herein shall be construed to require 1inch to provide consultations, support services or updates, upgrades, bug fixes or modifications to the Public API or Public Endpoints.

1 inch reserves the right to change the method of access to the Public APIs and/or Public Endpoints at any time to ensure the safety and security of 1 inch DevPortal environment or for any other reason at 1 inch's sole discretion without any prior notice. 1 inch reserves the right to change, suspend, or discontinue the Public APIs, Public Endpoints, 1 inch DevPortal tools and Documentation, in whole or in part, at any time, including the availability thereof, without notice to the User.

Notwithstanding anything above mentioned, 1inch reserves the right to immediately suspend or terminate your access to the Public API, Public Endpoints and the Service for any reason without any prior notice

11. Confidentiality

We may disclose to you or make available information on without limitation, research and development plans and results, software, databases, technology, inventions, trade secrets, technical information, know-how, plans, specifications, methods of operations, product and service information, product and service availability, pricing information, financial, business and marketing information and plans (collectively, "Confidential Information").

You agree that you shall not, directly or indirectly, use, permit use of, disclose, discuss, publish, or disseminate in any manner, any Confidential Information at any time and shall use their best efforts to protect and maintain the confidentiality of the Confidential Information contemplated herein.

You shall not disclose any such Confidential Information to any person or entity, except to personnel under your control who need to know the Confidential Information to assist you, or act on your behalf, to exercise your rights or perform its obligations under these Terms. You shall be responsible for any breach caused by any of your personnel.

Your obligations with regard to Confidential Information will not apply to the extent that disclosure of such Confidential Information is required by applicable Law or a valid order issued by a court or governmental agency of competent jurisdiction. In such cases, you must inform us in writing as soon as possible, and you must limit the disclosure of the Confidential Information to only what is necessary to comply with such an order.

12. Limitation of Liability

Under no circumstances shall we or any of our officers, directors, employees, contractors, agents, affiliates, or subsidiaries be liable to you for any indirect, punitive, incidental, special, consequential, or exemplary damages, including (but not limited to) damages for loss of profits, goodwill, use, data, or other intangible property, arising out of or relating to any access to or use of 1inch DevPortal and the Service, nor will we be responsible for any damage, loss, or injury resulting from hacking, tampering, or other unauthorized access to or use of 1inch DevPortal and the Service, or from any access to or use of any information obtained by any unauthorized access to or use of 1inch DevPortal and the Service.

We assume no liability or responsibility for any: (a) errors, mistakes, or inaccuracies of content; (b) personal injury or property damage, of any nature whatsoever, resulting from any access to or use of

1inch DevPortal and the Service; (c) unauthorized access to or use of any secure server or database in our control, or the use of any information or data stored therein; (d) interruption or cessation of function related to 1inch DevPortal and the Service; (e) bugs, viruses, trojan horses, or the like that may be transmitted to or through 1inch DevPortal and the Service; (f) errors or omissions in, or loss or damage incurred as a result of, the use of any content made available through 1inch DevPortal and the Service; and (g) the defamatory, offensive, or illegal conduct of any third party.

Under no circumstances shall we or any of our officers, directors, employees, contractors, agents, affiliates, or subsidiaries be liable to you for any claims, proceedings, liabilities, obligations, damages, losses, or costs in an amount exceeding the greater of (i) the amount you paid to us in exchange for access to and use of 1inch DevPortal and the Service, or (ii) \$100.00. This limitation of liability applies regardless of whether the alleged liability is based on contract, tort, negligence, strict liability, or any other basis, and even if we have been advised of the possibility of such liability. Some jurisdictions do not allow the exclusion of certain warranties or the limitation or exclusion of certain liabilities and damages. Accordingly, some of the disclaimers and limitations set forth in these Terms may not apply to you. This limitation of liability shall apply to the fullest extent permitted by law.

13. Indemnification

You agree to hold harmless, release, defend, and indemnify us and our officers, directors, employees, contractors, agents, affiliates, and subsidiaries from and against all claims, damages, obligations, losses, liabilities, costs and expenses arising from (a) your access to and use of 1inch DevPortal and the Service; (b) your violation of these Terms, the right of any third party, or any other applicable law, rule, or regulation; and (c) any other party's access and use of 1inch DevPortal with your assistance or using any device or account that you own or control.

14. Disclaimer of Warranty

You expressly understand and agree that your use of 1inch DevPortal is at your sole risk. We expressly disclaim all representations and warranties, express, implied or statutory with respect to 1inch DevPortal, the Service, and the proprietary or open-source code. We specifically expressly disclaim any representation or warranty, express, implied or statutory, including without limitation, any representations or warranties of title, non-infringement, merchantability, usage, security, suitability or fitness for any particular purpose, or as to the workmanship or technical coding thereof, or the absence of any defects therein, whether latent or patent. We do not represent or warrant that 1inch DevPortal, code and any related information are accurate, complete, reliable, current or error-free.

The Service, including the API, is provided on an "as is" and "as available" basis, without warranties of any kind, either express or implied, including, without limitation, implied warranties of merchantability, fitness for a particular purpose or non-infringement. You acknowledge that no advice, information, or statement that we make should be treated as creating any warranty concerning the Service. We do not endorse, guarantee, or assume responsibility for any advertisements, offers, or statements made by third parties concerning the Service.

15. Force Majeure

Neither 1inch, nor our partners, affiliates and employees shall be liable for damages, delay or failure to your use of 1inch DevPortal, the Service or in performing our obligations hereunder if such delay or failure is caused by conditions beyond our reasonable control including, but not limited to Acts of God, government restrictions, wars, cyber attacks, third-party suppliers, and subcontractor's failures (e.g. electricity shut down), from insurrections, burglary and/or any other cause beyond our reasonable control.

16. Governing Law and Arbitration

IMPORTANT NOTE REGARDING ARBITRATION: WHEN YOU AGREE TO THESE TERMS BY USING OR ACCESSING THE INTERFACE, YOU ARE AGREEING TO RESOLVE ANY DISPUTE BETWEEN YOU AND 1INCH THROUGH BINDING, INDIVIDUAL ARBITRATION RATHER THAN IN COURT. AND YOU AGREE TO A CLASS ACTION WAIVER, BOTH OF WHICH IMPACT YOUR RIGHTS AS TO HOW DISPUTES ARE RESOLVED.

Choice of Law. These Terms are governed by and will be construed under the laws of the British Virgin Islands, without regard to principles of conflict of laws, govern the Terms and any Dispute between you and us. Any Dispute under these Terms shall be finally settled by Binding Arbitration (as defined below).

Arbitration. The User and 1inch shall cooperate in good faith to resolve any Dispute, controversy or claim arising out of, relating to or in connection with these Terms, including with respect to the formation, applicability, breach, termination, validity or enforceability thereof (a "**Dispute**").

Any unresolved Dispute arising out of or in connection with these Terms shall be referred to and finally resolved by arbitration under the rules of the London Court of International Arbitration (LCIA), which rules are deemed to be incorporated by reference into this Section 9 to the extent they are consistent with it. Any Dispute arising from or relating to the subject matter of these Terms shall be finally settled in London, United Kingdom, in English, in accordance with the LCIA Arbitration Rules. Unless we agree otherwise, the arbitrator may not consolidate your claims with those of any other party.

Authority of Arbitrator. As limited by these Terms and applicable arbitration rules, the arbitrator will have: (a) the exclusive authority and jurisdiction to make all procedural and substantive decisions regarding a Dispute; and (b) the authority to grant any remedy that would otherwise be available in court. The arbitrator may only conduct an individual arbitration and may not consolidate more than one individual's claims, preside over any type of class or representative proceeding or preside over any proceeding involving more than one individual.

Process. You and the 1inch agree that each will notify the other, in writing, of any Dispute within thirty (30) days of when it arises so that the parties can attempt, in good faith, to resolve the Dispute informally. Notice to 1inch shall be provided by sending an email to csm@1inch.io. Your notice must include (1) your name, postal address, and email address; (2) a description of the nature or basis of the Dispute; and (3) the specific action that you are seeking. If you and the 1inch cannot resolve the Dispute within thirty (30) days of 1inch receiving the notice, either you or 1inch may commence an arbitration proceeding as prescribed herein. You and 1inch agree that any arbitration or claim must be commenced or filed within one (1) year after the Dispute arose; otherwise, you and the 1inch agree that the claim is permanently barred (which means that you will no longer have the right to assert a claim regarding the Dispute).

17. Miscellaneous

Entire Agreement. These Terms, any other terms and conditions incorporated herein by reference, constitute the entire agreement with respect to 1inch DevPortal and supersedes any prior agreements, oral or written.

Assignment. You shall not wholly or partly assign or pledge to assign any interest or rights granted hereunder to any third party without the prior written approval of 1inch. 1inch may freely assign or otherwise transfer any of its rights or delegate any of its obligations under these Terms. These Terms and the rights and obligations established herein shall be binding upon and inure to the benefit of 1inch and its heirs, successors in interest, executors, contractors, beneficiaries and permitted assigns.

Severability. If any provisions of these Terms are found invalid or unenforceable in any jurisdiction, such ineffectiveness or unenforceability shall not affect the validity or enforceability of such provision in any other jurisdiction or the validity or enforceability of any other provision in that or any other jurisdiction.

Survival. Upon termination of these Terms for any reason, all provisions of these Terms that by their nature are continuing will survive such termination.

Changes. We may amend any portion of these Terms at any time by posting the revised version of these Terms with an updated revision date. The changes will become effective and shall be deemed accepted by you, the first time you use or access 1inch DevPortal after the initial posting of the revised Terms and shall apply on a going-forward basis with respect to your use of 1inch DevPortal including any transactions initiated after the posting date. If you do not agree with any such modification, your sole and exclusive remedy is to terminate your use of 1inch DevPortal.
